

# CONDITIONS OF ENTRY

## SAM KERR FOOTBALL CENTRE

Football West is committed to providing a safe and enjoyable environment for all patrons and staff.

Entry to the Sam Kerr Football Centre is subject to the conditions below. These should be read in conjunction with the conditions of sale appearing on each ticket or terms and conditions of the membership/booking. The Sam Kerr Football Centre is Private Property.

By entering the Sam Kerr Football Centre, all patrons, hirers, and visitors agree to abide by the venue's Terms and Conditions of Use. Any breach of these Terms and Conditions — including unauthorised access, misconduct, damage to property, or failure to follow directions from Centre Management — may result in immediate removal from the premises and the application of a banning period at the discretion of Football West. Football West reserves the right to refuse entry or future bookings to any individual or organisation found to be in breach of these conditions.

### Rights of Management

Football West reserves the right to:

- Inspect any bags, clothing or other items at entry or within the Sam Kerr Football Centre at any time
- Refuse entry of prohibited items which may cause injury or public nuisance
- Refuse entry to any:
  - Unauthorised person
  - Person deemed to be intoxicated, disorderly, or engaging in anti-social behaviour
  - Person who is subject to a current banning notice
  - Person who purchases an event ticket from an unauthorised ticketing agent or source
  - Person is unlawful, dangerous or inappropriate
- Remove from the premises any person who, in the reasonable opinion of management, is likely to disrupt or cause a nuisance to the operations of the Sam Kerr Football Centre
- Modify the conditions of entry as required by the event promotor or event requirements

### Screening

It is a condition of entry that all patrons consent to having their bags, clothing or other items checked on entry or within the Sam Kerr Football Centre at any time.

Any patron found to be in possession of an illegal prohibited item will be reported to police.

Any patron who fails to comply with the screening may be refused entry or removed from the venue.

Patron access will be managed via screening and checks, which may include electronic equipment scanning and/or personal body checks and any other checks deemed reasonable.

### Attire

As a minimum for general public areas, patrons must be appropriately clothed in clothing suitable for the activity in which they are participating.

Patrons wearing or displaying inappropriate or unauthorised commercial, political, or religious logos/images that are offensive may be denied entry or asked to remove such items.

Wearing of 'colours' on 'insignia' signifying belonging to any outlaw motorcycle clubs or other groups as designated by police is prohibited.

Patrons attempting to conceal their identity with a scarf, balaclava, mask or other item unless for a religious, medical or other justifiable reason may be refused entry, undergo a security check, and/or be removed from the facility.

### Prohibited Conduct/Patron Removal

A person may be removed from the Sam Kerr Football Centre where they:

- Are under the influence of alcohol or illicit drugs and/or engage in disorderly, offensive, anti-social, disruptive, unlawful, or inappropriate behaviour
- Use foul or abusive language or make racial, discriminatory, or threatening remarks or gestures
- Accessing restricted areas including the playing surfaces, high performance areas, administration, and meeting rooms.
- Commit any act of vandalism, littering, or property damage
- Enter an area of the venue without proper authorisation
- Fail to comply with a lawful request from staff or other authorised personnel
- Place any unauthorised poster, banner, or other advertising or political material on any part of the venue
- Conduct unauthorised surveys or soliciting of members of the public
- Undertake unauthorised promotional or commercial activities in or outside of the venue
- Make any unlawful recording of the event or other patrons
- Fail or refuse to submit to a lawful search or inspection at entry points or within the venue upon request

No ticket refund will be paid to patrons removed from the venue.

Persons may be referred to police where appropriate.

### Prohibited Items

The following items are prohibited from the venue, unless specifically authorised by management:

- Weapons of any kind
- Alcohol and drugs
- Cans/glass
- Musical instruments/whistles
- Unauthorised temporary signage and promotional products
- Flags/banners over one (1) metre
- Fireworks/flares/laser lights/pyrotechnics
- Rollerblades/skateboards/scooters/helmets
- Professional cameras/audio recording equipment/video cameras
- Animals, except for authorised assistance animals
- Any large items that cannot be placed under a seat
- Umbrellas
- Prams
- Any other item that in the opinion of Football West could cause damage, harm or public nuisance
- Flares or smoke bombs/devices

# CONDITIONS OF ENTRY

## Alcohol

The Sam Kerr Football Centre is licensed and, as such, the following provisions apply:

- Alcoholic beverages must not be taken into or out of the venue
- Alcohol, if served, must only be consumed in the designated areas
- Alcohol must not be consumed in the designated 'Alcohol Free' areas
- It is an offence for Minors to purchase or consume alcohol, or for a person to supply alcohol to a Minor
- Breaches of these conditions may result in the person(s) being reported to the police and/or removed from the venue. Penalties may apply under the *Liquor Licensing Act 1988*.

## Food and Non-Alcoholic Beverages

Deliveries and product from external caterers and commercial outlets are generally not permitted in the venue.

Decisions about whether such products will be permitted are at the discretion of the Sam Kerr Football Centre management.

Patrons may bring homemade food items into the venue provided it is packed appropriately and can be viewed by staff or security personnel if requested. This does not apply to food or beverages for patrons with special dietary requirements, provided that such food or beverages are not packaged in prohibited containers.

Thermoses containing tea and coffee may be allowed but may be checked for liquor licensing purposes.

## Smoking

Smoking is not permitted anywhere in the venue, except in designated smoking areas.

This includes electronic cigarettes, personal vaporisers, electronic nicotine delivery systems, or other battery powered vaporisers.

## Tickets

Tickets must be retained at all times.

Any tickets that have been damaged, defaced, or purchased from an unauthorised agent will not permit the holder to be admitted into the Venue.

Patrons are only authorised to access the seats/areas of the Venue for which they have been ticketed.

Where the ticket is for general admission, no representation is made that there is seating available within the Venue.

Patrons who have purchased a concessional ticket must be able to provide valid proof for the concession (i.e. proof of age identification or concession card) upon entry or when requested.

## Payment

The Sam Kerr Football Centre is a cashless venue. Payment is to be made by card only.

## Underage Persons

Persons under the age of 12 must be under the supervision of an adult parent or guardian at all times, throughout all events.

## Use of Images

By entering the Sam Kerr Football Centre, patrons give consent to their image, likeness or voice being captured and used as part of any recording of an event or any other purposes without compensation or any kind.

## Electronic Surveillance

In order to enhance security, protect the safety of persons, and ensure compliance with conditions of use, surveillance equipment (including CCTV) is in operation within and surrounding the Venue.

By entering the Venue, patrons give consent to their information (including images) being recorded and disclosed to third parties, including law enforcement agencies and government organisations holding events.

All personal information is managed in accordance with the *Privacy Act WA 1996*.

## Risk and Liability

Patrons enter the Venue at their own risk.

Each patron assumes all risk of any damage or loss (including property damage, personal injury, economic, and consequential loss) however it arises at the Venue.

Each patron brings personal effects into the Venue at their own risk and neither Football West nor VenuesWest will be responsible to any damage to or loss or theft of a patron's personal property.

Persons are bound by our constitution / by-laws / rules / policies and any disciplinary procedures;

## Photographic, Video, and Audio Equipment

The use of photographic, video, or audio equipment (including mobile phones with camera interfacing) is not permitted:

- For commercial purposes without prior authorisation from Football West
- In the following areas of the Venue:
  - Changerooms
  - Toilets/Shower
  - High Performance Area

## Booking Process & Access Control

All venue bookings at the Sam Kerr Football Centre must be made either online through the official Sam Kerr Football Centre booking portal or directly with Venue Management.

Walk-in or informal requests will not be accepted. Bookings are only confirmed once full payment (if applicable) and written confirmation have been received from Centre Management.

Access to pitches and other venue facilities is strictly limited to approved hirers and their authorised participants during the confirmed booking period.

Any unauthorised use of the venue, including entry outside of allocated booking times or use of spaces without prior approval, is prohibited and may result in removal from the premises, cancellation of future bookings, and/or additional fees being applied.

## Participation at Own Risk

Participation in sport and physical activity involves inherent risks, including slips, falls, collisions, and other causes of injury.

By entering and using these facilities, all participants and spectators do so entirely at their own risk. The venue owner and operator accept no responsibility for injury, loss, or damage arising from participation or attendance, except as a result of their negligence.

By participating, you confirm that you are medically and physically fit for the activity and that you will not engage in any conduct that may endanger yourself or others.
